



2017 Sound Cheque Showcase Guidelines

Sunday, November 5, 2017 | Location TBD

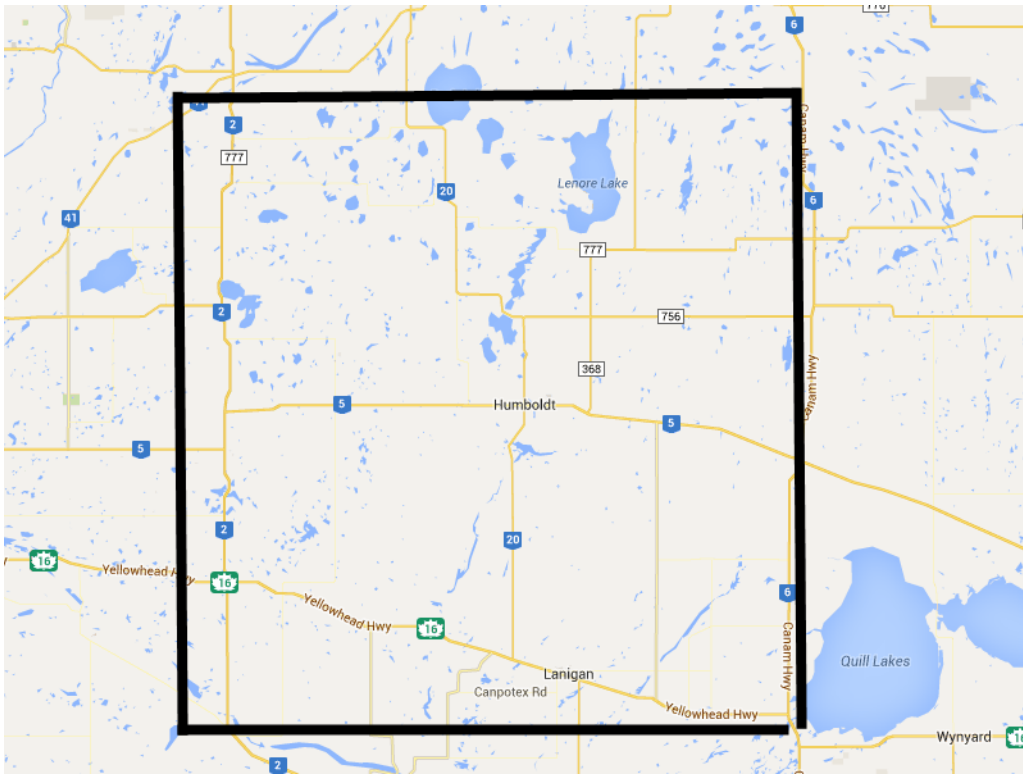
The winner of the showcase wins one personalized recording session with professional producer, Randy Woods at his studio in Saskatoon, SK (\$2,500 value).

Video submissions will be reviewed and up to five participants will be selected for live performances in front of the judges where ONE WINNER will be chosen. Please refer to the following guidelines.

- 1) This event is intended to showcase local VOCAL talent – accompaniment can be by pre-recorded music tracks or live instruments. If you are also a musician and prefer to provide your own accompaniment, please note that judges will base the majority of their total score on your vocal talent only.
- 2) Interested participants must submit a video recording with an introduction and sample of your vocal talent. These videos will be reviewed by a panel of judges before accepting the applicant into the Showcase. Only those applicants who have been contacted and confirmed will be eligible to participate in the showcase.
- 3) The showcase is open to participants at least 16 years old and residing within the 107.5 Bolt FM listening area (see over for general map).
- 4) A setup time of five minutes will be allowed between performances at the showcase.
- 5) Sound equipment will be provided but all contestants must supply their own instruments if applicable. If accompaniment is pre-recorded, it must be provided to the sound technician on CD, MP3 player, or USB drive. It is suggested that you arrive early and ensure the sound technician can play your music and/or accommodate your instruments.
- 6) All showcase participants must report to the (venue to be determined) at least thirty minutes before the start time to receive instructions from the judges.
- 7) Performers will perform in front of a panel of judges and their decision will be final. No Judges Score Sheet will be available to any contestants following the contest. Comment sheets will be available upon request.
- 8) Participants should be prepared to perform up to two songs. Original songs (songs not previously recorded by anyone) are encouraged but not required.
- 9) Judging will be based on: Stage Presentation-15 points, Audience Appeal- 5 points, Ability-25 points, and Appearance-5 points.
- 10) The number of participants will be limited to not more than five acts in the competition as pre-selected by the judges based on video submissions.
- 11) This showcase is open to amateur individuals only. Professional entertainers or artists who have previously been professionally recorded and played on Canadian radio are not eligible to participate. Past participants may participate provided they meet all guidelines.
- 12) Members of Arts Humboldt and their immediate families are not eligible to participate.

Videos on USB or DVD may be dropped off at the Uniplex administration desk or E-Mail soundcheque@artshumboldt.com for upload instructions. All performances are expected to be family-friendly. All entries are subject to final approval by Arts Humboldt.
